- ☐ I surrender my Commercial Driver's License (CDL) to obtain a WV Identification Card and understand my driving privileges will be canceled. I must complete and pass both the knowledge and skills tests to be eligible for a WV Driver's License. **(An applicant who has obtained an identification card while their CDL was suspended or revoked can reapply for a new CDL without retesting if the driving privilege was reinstated within thirty-six months of obtaining the Identification Card.)**
- ☐ I surrender my Class E license to obtain a WV Identification Card and understand my driving privileges will be canceled. I must complete and pass both the knowledge and skills tests to be eligible for a WV Driver's License. **(An applicant who has surrendered their non-commercial driver's license in order to obtain an identification card can reapply for a non-commercial driver's license without the requirement of retesting, if otherwise eligible, within thirty-six (36) months of obtaining an identification card.)**
- ☐ I wish to renew my CDL, but due to a temporary medical condition, I am unable to obtain the required Medical Examiner's Certificate (MEC).
I understand the following:
 - My CDL will be temporarily downgraded to a Class E, non-CDL license,
 - I will have a **five (5) year** window in which to reapply for a CDL without being required to retest,
 - I must provide a new MEC (valid for more than 30 days) when applying and I must provide a letter from a medical examiner stating that I am released from the medical condition that prevented me from obtaining an MEC to safely operate a Commercial Motor Vehicle (CMV),
 - Once these requirements have been met, my license will be upgraded to a CDL.
- ☐ I permanently surrender my CDL for a Class E license.
- ☐ I surrender my Graduated Driver's License (GDL) and understand that I will need parental or guardian consent before reapplying if under age 18.
- ☐ I surrender my Driver's License (non-CDL) due to medical reasons. I understand I will be required to obtain a letter from a medical examiner releasing me from the condition that prevented my holding a Driver's License and the letter *must* state that I can safely operate a motor vehicle. I understand once these requirements have been met, and the medical hold is removed from my Driver's License, I can proceed with the re-examination process.
