Responses to Questions from Vendors

Question 1

Non-Conforming Sub-lots (Section 3.2.3.3 on the Pickup by Agency): Within the section two different methods of price reduction is detailed... the first outlines a method of reducing the number of tons to be paid at the full price, the second outlines a method which reduces the cost paid. Just curious why the necessity for both to be described and which method is actually being used.

Answer 1

The first method described in Section 3.2.3.3 (Non-Conforming Sub-lots) determines the total adjusted price for the specific quantity picked up from a stockpile with a single non-conforming sub-lot. The second method described is to be used in addition to the first method in the event there are two or more non-conforming sub-lots within the stockpile.

Example: if there are two sub-lots of non-conforming material within the stockpile, the adjusted payment on the quantity to be picked up is to be determined separately for each non-conforming sub-lot using the first method described above. Add the two adjusted payments together and subtract from the total price to be paid before the adjustment for tonnage picked up.

Question 2

Section 4.4 – Contract Award Transition: Why was the language changed? As written, the DOH can essentially hold a vendor to an indefinite amount of time.

Answer 2

Our Contract Transition language changed as it was contradictory to the Delivery Order Limitations language in Section 3 of the Terms and Conditions. An ADO can be valid for up to one year from the issued date.
