As a result of the coordinated efforts between the West Virginia Department of Transportation (WVDOT) and various other federal, local, and regional freight stakeholders, we are pleased to submit the State's Critical Freight Corridors.

Per 23 U.S.C. 167(g), and other pertinent Federal regulations, the following tables have been attached which identify Critical Rural Freight Corridors and Critical Urban Freight Corridors in accordance with the current FHWA guidance covering the designation and certification requirements.

Critical Rural Freight Corridor (CRFC) Certificate
